# INSTITUTE FOR DISPUTE RESOLUTION (IDR)



### Steven Fulop, Mayor, City of Jersey City

Steven Michael Fulop is the 49th and current Mayor of Jersey City, New Jersey — named in 2017 the second most diverse city in the nation and the soon-to-be largest city in New Jersey. Since Mayor Fulop took office in 2013, Jersey City residents have seen four consecutive years of stable taxes and four consecutive credit rating upgrades. Meanwhile, more than 300 new police officers have been hired, nearly 1,500 units of affordable housing built or approved, recreation expanded with nearly 30 new programs, and more than \$6 million invested in parks and open space. During his time in office, Mayor Fulop has shown what smart, progressive leadership can accomplish.



### Marcos D. Vigil, Deputy Mayor, HEDC at City of Jersey City

Marcos D. Vigil serves as Deputy Mayor for Housing, Economic Development & Commerce under Mayor Steven Fulop in Jersey City. As such, he oversees economic development and business creation, and developing strategies for sustainable development and affordable housing. He is also a Commissioner of the Jersey City Municipal Utilities Authority, represents the City as a member of the New Jersey State League of Municipalities' Legislative Committee and as the Mayor's Alternate Trustee for the North Jersey Transportation Planning Authority. Prior to his role with Jersey City Marcos served as Deputy Secretary of State of New York during Governor Andrew Cuomo's first term.



#### Sandra Bolden Cunningham, Senator, New Jersey

Sandra B. Cunningham was elected to the State Senate by the people of the 31st Legislative District in 2007. She is the widow of the late Glenn D. Cunningham, a distinguished statesman who was the Mayor of Jersey City and the State Senator of the 31st Legislative District. Senator Cunningham holds the distinction of becoming the first woman from Hudson County to serve in the New Jersey State Senate. She is a member of the Senate Leadership, serving as Deputy Majority Leader. She is also Chairwoman of the Higher Education Committee, a member of the esteemed Committee on Budget-Appropriations, and Labor Committee.



#### Thomas H. Kean, Jr., Senator, New Jersey

Senator Thomas H. Kean, Jr. represents District 21, which includes portions of Morris, Somerset and Union counties. Senator Kean was chosen by his colleagues to serve as the Senate Minority Leader for the 2017-2018 Legislative Session; it is a position he has held since 2008. The senator is a member of the Senate Higher Education, the Senate Commerce and the Legislative Oversight Committees. Senator Kean is a graduate of Dartmouth College. He has completed his Doctoral Studies, A.B.D., in international relations at Tufts University's Fletcher School of Law and Diplomacy, where he also received his M.A.L.D. and was employed as a Graduate School instructor.



#### Sue Henderson, President, NJCU

In 2012, Sue Henderson became the twelfth president and first woman to become President at New Jersey City University. Now in her sixth year, she has accomplished a range of transformational initiatives, including the creation of NJCU School of Business and relocation to a 70,000-square foot, state-of-the-art facility in Jersey City's financial district. She spearheaded the implementation of a \$350 million West Campus plan which features a fully integrated, pedestrian-friendly, mixed-use development for a student residence hall, academic building and performance arts center, a fitness center, supermarket, and shops and restaurants; and hired one quarter of the faculty within the past three years in areas identified as critical to meeting academic needs in high-demand fields of study.



#### Honorable Kim Guadagno, Partner, Connell Foley
