## **NUMBER OF POSITIONS AVAILABLE:** One (1)

**<u>DUTIES:</u>** Under the supervision of the Attorney General and the Executive Assistant Attorney General, this Senior Counsel position will be responsible for coordinating the work of the Department of Law and Public Safety (LPS) relating to firearm safety. That includes working with attorneys across the Department on civil enforcement lawsuits, consumer protection actions, and legislative and policy initiatives relating to protecting New Jerseyans from gun violence, as well as helping to coordinate related criminal and law enforcement initiatives. The Senior Counsel will work closely with LPS divisions, the Office of the Governor, and executive branch agencies, and will perform or assist with other projects and tasks as needed.

## REQUIREMENTS

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorneyat-Law in the State of New Jersey is required.

**EXPERIENCE:** Four (4) years of professional legal experience as an attorney at law of the State of New Jersey in the area of the specialty or, three years of professional legal experience as an attorney for State or Federal administrative agencies which shall have involved a significant amount of the specialized legal work, or, two years of unique specialized legal experience.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**RESUME NOTE:** Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
