NUMBER OF POSITIONS AVAILABLE: Two (2) – Section preference required.

EMPLOYMENT LITIGATION SECTION DUTIES: Under the supervision of Assistant Attorneys General and the Deputy Director, the Section Chief of the Litigation Practice Group Employment Section will supervise the work of the Section, which provides legal counsel and representation for client agencies in employment litigation matters. The Section Chief will also supervise the work of the Assistant Section Chiefs and will be responsible for the overall operation and administration of the Section; evaluate the performance of all Deputy Attorneys General in the Section; work with and manage outside counsel in employment litigation, as needed; and perform other related duties as assigned or required.

APPELLATE SECTION DUTIES: The Litigation Practice Group Appellate Section handles appellate matters in the Litigation Practice Group and reports to the above Assistant Attorneys General and Deputy Director The Section Chief will be responsible for the overall administration and management of the Section; supervise the work of the Assistant Section Chief; evaluate the performance of the Deputy Attorneys General in the Section; assist in the preparation of briefs and oral argument, as needed; and perform other related duties as assigned or required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney-at-Law in the State of New Jersey is required.

EXPERIENCE: Five (5) years of experience as a practicing attorney, two (2) year of which shall have been in a supervisory capacity.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

PREFERENCE: Preference for the Employment Litigation Section will be given to candidates who possess strong employment litigation experience in both State and Federal court as well as supervisory experience. Please supplement the resume to outline both employment litigation and supervisory experience. Preference for the Appellate Section will be given to applicants who possess strong appellate experience in State and Federal Court as well as supervisory experience. Please supplement the resume to outline both appellate and supervisory experience.
